Team 1 is the team relegated from State League Reserves and are needing to regrade into Division 1. Teams 2-11 were based on Division 1 results from 2022. Teams 12-14 were randomly drawn out of a hat having not played in Division 1 in 2022.

Teams that finish first or second in their pool will remain in Division 1. Teams that finish $4^{\text {th }}$ in Pool C and Pool D will be relegated to Division 2. Winners of the Playoff games (PO1 and PO2) will remain in Division 1 and the loser of these games will also be relegated into Division 2.

## Ranking System

To determine rankings within the pool after the conclusion of pool play the following are used:

## Win ratio

The team with the highest win ratio (to three decimal points) will be awarded the higher placing in the Round Matches:

$$
\text { Win ratio }=\frac{\text { Matches won }}{\text { Matches played }}
$$

In the case of the teams being on equal wins at the end of the Pool Matches the following applies:

## Sets ratio

If teams are tied on points, the order of ranking will be determined by Sets Ratio. The team with the highest set ratio (to three decimal points) will be awarded the higher placing in the Round Matches:


## Point's ratio

If the tie still exists after the calculation of the Sets Ratio, the order of ranking will be determined by Points Ratio. The team with the highest Points ratio (to three decimal points) will be awarded the higher placing in the Round Matches:

$$
\text { Point ratio }=\frac{\text { Points won }}{\text { Points won }+ \text { Points lost }}
$$
