4.0 4.1	FOLLOW UP ACTIONS FROM LAST MEETING DF noted that the tentative Assessor/Mentors list and form was almost	DF/OG
	ready, just that the people in the list were not aware yet of their possible Assessor/Mentor status. It was said that potential assessors/mentors need to accept the responsibility and that it was all right if they declined to participate. It was discussed if they should receive an honorarium and that it was pertinent to talk to Robyn regarding this. Mentors would be able to sign the log sheet and provide feedback (mostly level 2s) and Assessors would additionally be able to assess and approve candidates (level 3s and 4s).	JM/KW
4.2	It was noted that the only two people outside the committee that are beach refereeing seriously are Derek Scales and Jordan Fancote. It was also said that that unlike WA, other states' Beach Open have a full cohort of Referees during the entire competition where we only have referees for the finals. The idea of having a referee training session after state teams beach training was discussed and that it would have to be organized in collaboration with Pathways. Talking about developing beach referees and working alongside juniors and state teams started a big tangent regarding referee development and the status of Junior League and why we should not assess referees at Junior League. The reasoning was that there are no referee stands, the scoresheet is not the official one, and the entire refereeing is very lax. As a conclusion, it was noted that the beach players themselves need to be included in some sort of think tank to understand their view on refereeing beach competitions. It was decided that it would be a good opportunity for DF and WD to attend the next Beach Committee meeting on the 3 rd of April and discuss having referees in the Beach Volleyball competitions. 	standard but it was unclear if the sponsors would be legible. It was	
	decided that this is a club problem, not a VWA/RC problem.	JM

	gets greenlighted by the RC before use.
