1. Introduction

The Volleyball WA High Schools Beach Cup is open to all Western Australian schools and high school students. Participants compete in beach volleyball on one day, with the competition being held once in Term 1 and once in Term 4.

2. Child Safeguarding

VWA is a Child Safe Organisation which aims to safeguard the well-being of all children and young people who participate in our sport. All participants, officials and staff are required to comply with the VA Safeguarding Children and Young People Policy (**Section 9**) and abide by the VWA Codes of Conduct (**Section 9**).

2.1 Working With Children Check Policy

- The VWA Working with Children Check Policy (**Section 9**) applies to all VWA employees, contractors, volunteers and members, and all other people or organisations which by agreement or otherwise, are bound to comply with this policy.
- This policy applies to behaviour occurring during VWA business, activities, competitions and events, including the VWA Schools Beach Cup.

2.2 Photography and Videography Policy

- All participants, officials and staff are required to comply with the VWA Photography and Videography Policy (Section 9). This policy applies to conduct and behaviour when obtaining a photograph(s) and/or video recording for the purpose of VWA business, activities, competitions and events.
- VWA recognise it is common practice for people to take a photograph(s) or a video(s) of people participating in sport and that typically people are doing so for acceptable reasons and are using appropriate methods.
- In Australia, there are no laws specifically prohibiting photography and filming people (including children) in public places. It is a legitimate pursuit to film and take photos at sporting events. The laws governing the taking of photograph(s) and filming exist to safeguard the privacy and safety of people (including children) from exploitation and inappropriate use of their image without placing undue restrictions on legitimate activities.
- VWA recognise that most people take photographs and/or videos of special moments including participation in sport. It is important that the volleyball community understand their responsibility to ensure any images taken are in accordance with this basis and no other.
- If you require any further information or have concerns or questions, please ensure you contact Volleyball WA.

2.3 Photography and Videography at WA Schools Beach Cup

• If permission is denied or not obtained from the school / individual, then Volleyball WA will instruct the authorised photographers / video operators that no photos / videos are permitted of the school / individual and that no photos / videos of the school / individual are used in print or online communications produced by Volleyball WA.

2.4 Social Media Addendum

VWA supports the Volleyball Australia Social Media Policy (February 2022) and will
endeavour to ensure compliance with the Volleyball Australia Social Media Policy and its
subsequent dissemination and application with VWA staff and members.

3. Key Dates and Venues

3.1 Competition Date

• The competition will take place on Sunday, 27 October 2024.

3.2 Competition Venues

- 4-a-side: City Beach (North side of Clancy's), 187 Challenger Parade, City Beach.
- Pairs: Inner City Beach, 180 Charles Street West Perth.
- A venue layout map will be available on the day for court numbers.

4. Event Entry

4.1 Divisions

• The competition will be divided by format (Pairs/4-a-Side), gender (Boys and Girls), year groups (Year 7/8, Year 9/10, Year 11/12), and grades (A and B).

• Volleyball WA will endeavour to grade teams according to their entry. However, VWA reserves the right to change, merge or create additional divisions, subject to entries.

4.2 Event Entries

4.2.1 Event Entry Timeline

4.2.2 Entry Fees

- o 4-a-side teams: \$121.00 per team
- o Pairs: \$95.00 per team

4.2.3.2 Team Sheet Entry Requirement

• All schools entering teams in either the 4-a-side or Pairs competition must provide the **VWA Schools Coordinator** with a team list.

- The list must include each athlete's full first and last name, date of birth and primary contact email address.
- The team list template will be sent to schools following the close of entries.
- It is the responsibility of the school to ensure this list is completed by Tuesday, 22 October 2024.

4.2.4 How to Enter the Event - Individuals

4.2.4.1 Payment - Individuals

Payment is made at time of entry online.

- Individual teams that sign up for the competition cannot play if they have not paid for their team entry prior to the commencement of the competition.
- Teams will need to present a receipt of payment at the technical meeting or by an email to the VWA Schools Coordinator (schools@volleyballwa.com.au) if this has not been paid by the Tuesday before the event (22 October).

4.2.4.2 Membership - Individuals

- Teams that register as individuals (rather than schools) are expected to hold
 VWA membership (either Platinum or Gold) to be provided access to Personal Accident Insurance.
- The Personal Accident Insurance covers all players that are current VWA members only.

4.2.5 Late Entries

- NO LATE ENTRIES ARE GUARANTEED ACCEPTANCE. Late entries will only be accepted if it benefits the competition draw (i.e. to replace a bye or another withdrawal).
- Volleyball WA may refuse team entries if it benefits the structure of the tournament. Teams who enter first will take preference if such a situation occurs. As a result, VWA strongly encourages schools to enter early to avoid the possible removal of teams.

4.2.6 Withdrawals

- Teams may withdraw from the competition with no penalty until 4:00pm, Friday 18 October.
- o Teams withdrawing after this date will forfeit the full event entry fee.

4.3 Player Eligibility

- The Competition is open to all schools, country associations and community teams that qualify for school-aged tournaments (athletes must currently be enrolled in a secondary school).
- Athletes are only required to be of school age and do not necessarily have to attend the same school to compete.

4.4 Team Composition

4.4.1 Pairs

- o Two players per team only.
- o Both players must be of the same gender.
- o Players may play in one team only.

442 4-a-side

- o Teams must only have four players on the court but may have substitute players.
- o In the event of injury, a team may start the game with three players.
- o All players must be of the same gender.
- o Players may only play in one team only.

5. Injuries and Insurance

5.1 Insurance for Players

- Teams that register as individuals (rather than schools) are expected to hold VWA membership (either Platinum or Gold) to be provided access to Personal Accident Insurance.
- Players nominated by the school will be issued with a 'Bronze School Students Event Only' Membership. This membership will cover them with insurance in case of an injury during the event.

5.2 Injuries During the Event

- All personal accidents or injuries should be reported to the VWA representative on duty at the venue. The representative will complete an Injury Report Form for the injured participant that will be required to be submitted for any insurance claims.
- It must be ensured that the player's name is written on the scoresheet as this will be needed as proof of participation.
- VWA supplies First Aid kits, sunscreen, ice, water and Tournament Directors and or VWA staff who have HLTAID011 First Aid Certification.
- VWA recommends to schools to bring their own first aid qualified, trained staff.

6. Event Information

6.1 Competition Format

- Teams will play first to a number of points under a set time restriction.
- The VWA Tournament Director will announce the start and finish of all timed games.
- Teams switch sides on court during the match when the score reaches a multiple of 10 (for example, 4-6, or 13-7). This is to eliminate advantages caused by weather and court conditions
- For 4-a-side, substitutions may be made on a rotation basis or by normal substitution methods.

6.1.1 Round Matches

- o One (1) set first to 40 points, uncapped.
- o Games are limited to 15 minutes with a 5-minute warm-up.
- o One (1) 30 second time out per game per team.
- o If teams are even at the end of the game the next point wins there are no draws.

6.1.2 Semi Final Matches

- o One (1) set first to 40 points, uncapped.
- o Games are limited to 15 minutes with a 5-minute warm-up.
- o One (1) 30 second time out per game per team.
- o If teams are even at the end of the game the next point wins there are no draws.

6.1.3 Grand Finals

- o One (1) set first to 30 points uncapped.
- o A lead of two points is required.
- o No time limit (untimed).
- o One (1) 30-second time out per game per team.

6.2 Finals Format

- If a division has more than one pool, then a crossover finals format will apply
- If a division has more than two pools, the finals format will be determined based on number of pools and court availability. This will be determined by the VWA Beach Coordinator.

6.3 Forfeits

• If a team is not present five minutes into the start of the game, it will be declared a forfeit and result in a 1-0 loss.

6.4 Duty

- All teams will be assigned "duty" during the Competition. This means teams must referee and score for another game.
- We ask that all duties are taken seriously and completed professionally to ensure a highquality competition for all players
- Duty teams must provide their own whistles.
- It is the responsibility of the duty team to ensure that games start on time, ensure that all
 information is accurately filled out and the scoresheet is signed off. Captains of the
 winning team are responsible for returning the scoresheet to the VWA Tournament
 Director.
- Failure to provide duty personnel will result in a \$50.00 penalty and loss of one competition point.
- If it is your first time on the beach and you are unsure about any of the duty responsibilities, please let our tournament staff know.

6.5 Volleyball Rules

• The competition will follow the <u>FIVB</u> (<u>Federation Internationale de Volleyball</u>) <u>Official</u> <u>Volleyball Rules 2021-2024</u>.

6.6 Net Heights

- Girls 2.24m
- Boys (Year 7/8) 2.24m
- Boys 2.43m

6.7 Points System

• The following points system is in place to form the ladder of each division to select teams eligible for finals:

Win	Loss	Forfeit
3	1	0

• In the case of the teams being on equal points at the end of the Round Matches, the order of ranking will be determined by **set ratio**. The team with the highest set ratio (to three decimal points) will be awarded the higher placing in the Round Matches.

• If the tie still exists after the calculation of the sets ratio, the order of ranking will be determined by **points ratio**. The team with the highest points ratio (to three decimal places) will be awarded the higher placing in the Round Matches:

- If teams have played an unequal number of games, the team with the highest win ratio (to three decimal points) will be awarded the higher placing in the Round Matches:

7. Disputes, Protests and Appeals

7.1 Disputes

In a case of a dispute between schools and/or members, and/or competition and schools personnel and officials, one or both of the parties of the dispute may refer to the VA Complaints, Disputes and Discipline Policy and VWA Complaints, Disputes and Discipline Addendum (Section 9).

7.2 Protests

- Protests can occur during the game. A protest can be lodged regarding an incorrect rule interpretation but not ball handling/opinion.
- All protests will be resolved 'on-the-spot' by the VWA Tournament Director.
- The procedure to lodge a protest is as follows:

- At the conclusion of the point either the Coach or Team Captain may lodge a protest. The protest must be lodged immediately and cannot be lodged retrospectively.
- The Referee will suspend play and call upon the Tournament Director
- All protests must be resolved immediately by the Tournament Director.
- The result of the protest is final, and the teams must recommence the match immediately.
- If a team refuses to recommence the match, the team will forfeit the match and will be liable for the forfeit penalties.
- Should the protest be rejected by the VWA Tournament Director, the Team Coach/Captain that lodged the protest will be sanctioned with a penalty (Red Card).
- Any decision made on the day by the VWA Tournament Director is valid and a team/player in breach of a rule should accept this decision and play on.

7.3 Appeals

- If a Team/Player feels the interpretation of a rule result in a rejected protest was incorrect they are entitled to Appeal the decision.
- The following procedure will apply:
 - The school representative must submit an appeal in writing (by email) to the VWA
 Competitions Manager (competitions@volleyballwa.com.au)
 by 5:00pm on the next working day following the match.
 - The appeal should note the following information:
 - Situation outlined in detail.
 - Tournament Director's ruling.
 - The school's interpretation of the rule.
 - The Volleyball WA Beach Committee will respond to the school's letter within three business days.
- If the School representative wishes to protest the decision, the following procedure applies:
 - The school representative applies by written submission to the VWA Chief Executive officer.
 - The written submission must be within 24 hours of the decision reached. The
 written submission is to be accompanied by an Appeal fee payment of \$150.00
 (which will be returned to the school if the Appeal is successful; if the Appeal is
 unsuccessful then the Appeal fee payment will be retained by VWA).
 - If applicable, the VWA Chief Executive Officer will forward the protest information to the VWA Board of Management and/or consult with another person(s) that has the relevant expertise so as to ensure that an informed decision is made.
 - o The VWA Chief Executive Officer/VWA Board (if applicable) decision is final.

8. Risk Management

The effective management of risk is central to VWA achieving its Purpose and Mission. This means VWA must have a current understanding of its risks commensurate with risk analysis and completion of a risk assessment.

8.1 Risk Management Policies

- VWA adopts several policies to manage risk at the event.
- These policies include (but are not limited to):
 - o Concussion Management Policy
 - o Extreme Heat Policy

- o Lightning Policy
- o Needle Stick Injury Policy
- o Smoking Management Policy
- o Sun Protection Policy
- All policies listed above, and further related policies can be found on the Volleyball WA website (www.volleyballwa.com.au/about-us/policies)

8.2 Force Majeure

- For the purpose of these regulations a Force Majeure Event includes (but is not limited to) any or all of the following:
 - 'Acts of God' including flood, drought, earthquake, storm, cyclone, fire, explosion, epidemic; or
 - o COVID-19 outbreak; or
 - o War; or
 - o Terrorism; or
 - Riot or civil disturbances; or
 - o Permanent injunction of any duty constituted court of competent jurisdiction; or
 - Any fact, circumstances, matter or thing beyond the reasonable control of VWA
- If VWA is unable to perform, in whole or part in any obligation under these regulations of a Force Majeure Event, VWA is relieved of that obligation under these regulations to the extent, and the period it is unable to perform.
 - o In addition to the above, VWA has no obligation to refund any individual or team fees paid if it is unable to perform by reason of Force Majeure Event.
- Force Majeure may only be declared by the Volleyball WA Chief Executive Officer.
