Individual Recognition Awards will not be accepted if they are received after the closing date or do not use the correct form. Award nominees must not be the subject of an integrity matter at the time of nomination to be eligible for an award. Award nominees must always uphold all agreed behaviours and values of Volleyball WA. The closing date for nominations is Monday September 1, 2025, at 5:00pm.

4. Distinguished Service Awards

Affiliates and members can submit nominations for Distinguished Service Awards using the prescribed form on page 23. These nominations are ratified at the VWA Annual General Meeting (AGM) and presented at the VWA Annual Awards. A nomination can be submitted to the VWA Chief Executive Officer at *any point* prior to the VWA AGM.

Achievement Awards

Beach Volleyball

Beach athlete awards are collated by the VWA Pathways Manager and Event Coordinator, assisted by Volleyball Australia where required.

Individual Player of the Year (Male and Female)

Awards to the individual with the best seed index with a minimum of five tournaments played. *Note: Not awarded if both players from team of the year win.*

Team of the Year (Male and Female)

Awarded to the team with the best seed index with a minimum of five tournaments played.

Regional Player of the Year (Male and Female)

Awards to the individual with the best seed index with a minimum of three events players, who reside regionally.

Beach Youth Player of the Year (Male and Female)

Awarded based on the following criteria:

- ✓ Under 18 years of age
- ✓ Australian Resident
- ✓ Registered Volleyball WA Member
- ✓ Results of competition performance throughout the past 12 months
- ✓ Results at a Volleyball Australia Sanctioned Event (AYBVC, ABVSC, AJBVT, ABVT, Beach Pro Tour)
- ✓ Individual rankings
- ✓ International competition representation
- ✓ National Performance Program involvement (Performance Squad, AVA, Developing Volleyroo)



















Beach Junior Player of the Year (Male and Female)

- ✓ Under 23 years of age
- ✓ Australian Resident
- ✓ Registered Volleyball WA Member
- ✓ Results of competition performance throughout the past 12 months
- ✓ Results at a Volleyball Australia Sanctioned Event (AJBVT, ABVT, Beach Pro Tour)
- ✓ Individual rankings
- ✓ International competition representation
- ✓ National Performance Program involvement (Performance Squad, AVA, Developing Volleyroo)

Indoor Volleyball

Indoor Athlete Awards are collated by the VWA Pathways Manager and Competitions Coordinator, assisted by Volleyball Australia where required.

WAVL MVP Best and Fairest Awards (Male and Female per Division)

Each division of the WA Volleyball League (WAVL) awards a male and female MVP. This is voted upon by the first referee with consultation of both head coaches of each game using a 3-2-1 system (3 being the most outstanding player). Players are only eligible to receive the MVP Award for the division that they qualify to play the finals in. A player will be deemed ineligible for this award if given a suspension during the WAVL season.

At the end of the State League Season, all All-Star Team will be named with the players who received the most votes for their respective position. The positions are as follows:

- Outside Hitter x 2
- Middle Blocker x 2
- Setter x 1
- Libero x 1
- Opposite x 1

<u>Indoor Youth Player of the Year (Male and Female)</u>

Awarded based on the following criteria:

- ✓ Under 18 years of age
- ✓ Australian Resident
- ✓ Registered Volleyball WA Member
- ✓ Results of competition performance throughout the past 12 months



















- ✓ Results at a Volleyball Australia Sanctioned Event (AYVC, AJVC, AVSC)
- ✓ AVSL and/or International competition representation
- ✓ National Performance Program involvement (Performance Squad, AVA, Developing Volleyroo)

Indoor Junior Player of the Year (Male and Female)

- ✓ Under 23 years of age
- ✓ Australian Resident
- ✓ Registered Volleyball WA Member
- ✓ Results of competition performance throughout the past 12 months
- ✓ Results at a Volleyball Australia Sanctioned Event (AJVC)
- ✓ AVSL and/or International competition representation
- ✓ National Performance Program involvement (Performance Squad, AVA, Developing Volleyroo)

Indoor Beach Volleyball

The ten Indoor Beach Super League MVP Player Awards are determined by the Indoor Beach Federation: Female, Male and Mixed.

State Representation

State Representative Awards will be collated by the VWA Pathways Manager.

Perth Steel AVSL MVP Awards - Male and Female

The coaches of the Perth Steel AVSL Teams will submit a 3-2-1 vote (3 being the most outstanding player) to the VWA Pathways Manager after every game.

AYBVC, AYVC, AJVC & AVSL - Medal Winners

Medal winners will be acknowledged as per the outcome of competition finals.

International Representation

Recognition of all individuals (athletes, coaches, referees, and team personnel) who are members of Volleyball WA and who have represented Australia at a Senior FIVB International Competition.



















International Awards

Assessed by a Selection Panel comprising of a representative from the VWA Performance Pathways Committee, a representative from Volleyball Australia's Performance Department, and the VWA Chief Executive Officer.

<u>International Player of the Year – Beach</u>

Outstanding achievement by an athlete at international level based on the following criteria:

- ✓ Australian Resident
- ✓ Registered Volleyball WA Member
- ✓ International competition results in the past 12 months (e.g.: Olympic Games, World Championships, 1–5-star events, overseas universities, individual rankings).
- ✓ The individual is a role model for aspiring future athletes by contributing to off-court initiatives or advocacy.

<u>International Player of the Year - Indoor</u>

Outstanding achievement by an athlete at international level based on the following criteria:

- ✓ Australian Resident
- ✓ Registered Volleyball WA Member
- ✓ International competition results in the past 12 months (e.g.: Olympic Games, World Championships, professional leagues, overseas universities).
- ✓ The individual is a role model for aspiring future athletes by contributing to off-court initiatives or advocacy.



















Recognition Awards

Coach Awards

Assessed by a **Selection Panel** comprising of a VWA Board representative, a Department of Local Government, Sport, and Cultural Industries representative and a VWA Staff Management Representative, appointed by the CEO.

Junior Coach of the Year

Nomination Form

Eligibility:

- ✓ Have a valid Volleyball Australia Coach Accreditation
- ✓ Reside primarily in Western Australia
- ✓ Be under 19 years of age as of 31 December of the given year.

Criteria (Nominations must demonstrate two or more of the following):

- ✓ In the last two calendar years has been a first-time coach with a Volleyball WA State Team Program
- ✓ In the last two calendar years has coached at multiple levels and / or multiple codes
- ✓ Actively pursues and demonstrated personal and professional development.

Club / Community Coach of the Year

Nomination Form

Eligibility:

- ✓ Have a valid Volleyball Australia Coach Accreditation
- ✓ Reside primarily in Western Australia
- ✓ Be registered with, and actively coaching at a VWA Affiliated Club / Association

Criteria (Nominations must demonstrate three or more of the following):

- ✓ Coaches at multiple levels and across multiple codes
- ✓ In the last calendar year has raised the level of coaching within the Club / Association
- ✓ In the last calendar year has contributed to the development of Community / Club / Associations
- ✓ Actively pursues and demonstrated personal and professional development.



















Coach of the Year

Nomination Form

Eligibility:

- ✓ Have a valid Level 2 State or Level 3 Volleyball Australia Coach Accreditation
- ✓ Reside primarily in Western Australia

Criteria (Nominations must demonstrate three or more of the following):

- ✓ In the last calendar year has coached at AYBVC, AYVC and / or AVSL.
- ✓ In the last calendar year has coached at a national and / or international level (if possible, to do so in that year)
- ✓ Be registered with, and actively coaching at a VWA Affiliated Club / Association
- ✓ Actively contributes to the coach education and development of volleyball in WA as a presenter, mentor and / or VWA Coach Committee Member
- ✓ Actively pursues and demonstrated personal and professional development.

Referee Awards

Assessed by a **Selection Panel** comprising of a VWA Board representative, a Department of Local Government, Sport, and Cultural Industries representative and a VWA Staff Management Represented, appointed by the CEO.

The nomination form requires endorsement from the Chairperson of the VWA Referee Committee. Approval from either the Chairperson or their Representative is necessary to ensure that the candidate's nomination includes all relevant activities. The final selection of successful nominations rests with the Selection Panel.

Junior Referee of the Year

Nomination Form

Eligibility:

- ✓ Have a valid Volleyball Australia Referee Accreditation
- ✓ Reside primarily in Western Australia
- ✓ Be under 19 years of age as of 31 December of the given year.

Criteria (Nominations must demonstrate two or more of the following):

- ✓ In the last two calendar years has been a first-time referee at AJVC, AYVC or AYBVC
- ✓ In the last two calendar years has refereed at multiple levels and / or codes
- ✓ Actively pursues and demonstrated personal and professional development.



















Referee of the Year

Nomination Form

Eligibility:

- ✓ Have a valid Volleyball Australia Referee Accreditation
- ✓ Reside primarily in Western Australia

Criteria (Nominations must demonstrate three or more of the following):

- ✓ In the last calendar year has refereed at a Volleyball Australia sanctioned event (ABVT, AJBVT, AJVC, AJVC, AVSL, AYBVC, ABVSC or AVSC)
- ✓ In the last calendar year has refereed at a national and / or international level (if possible, to do so in that year)
- ✓ Be registered with, and actively refereeing within a VWA Affiliated Club / Association
- ✓ Referees at multiple levels and across multiple codes
- ✓ Actively contributes to the referee education and development of volleyball in WA as a presenter, mentor and / or VWA Referee Committee Member
- ✓ Actively pursues and demonstrated personal and professional development.

Referee Recognition Award

Nomination Form

This award is to recognise an individual who has demonstrated an outstanding effort as a Referee in the VWA Community (including regional WA) and does not necessarily qualify for the Junior Referee or Referee of the Year Awards.

Eligibility:

- ✓ Have a valid Volleyball Australia Referee Accreditation
- ✓ Reside primarily in Western Australia

Criteria (Nominations must demonstrate the following):

- ✓ Proven Involvement: Candidates must have a documented record of participation in VWA and/or VA Competitions, showcasing their commitment in the field.
- ✓ Contribution to Development: Nominees should actively contribute to the enhancement and development of referees, demonstrating a commitment to the growth and improvement of officiating standards.
- ✓ Integrity and Leadership: Individuals must consistently demonstrate integrity and leadership during refereeing activities, setting a positive example and upholding the values of fair play and respect.





















Administration Awards

Assessed by a **Selection Panel** comprising of a VWA Board representative, a Department of Local Government, Sport, and Cultural Industries representative and the VWA Marketing & Communications Manager.

Trevor Williams Volunteer Administrator of the Year

Nomination Form

This Award seeks to recognise the contributions made by an individual to volleyball through their outstanding service to the sport in the fields of administration and management.

Eligibility:

- ✓ Be a committee volunteer for a VWA Affiliated Club / Association
- ✓ Reside primarily in Western Australia

Criteria (Nominations must demonstrate two or more of the following):

- ✓ A proven record of achievement and / or performance to volleyball in WA
- ✓ Significant involvement in and commitment to volleyball in WA in the last year
- ✓ Has displayed the Volleyball WA values and behaviours in cooperation with VWA and throughout the WA volleyball community.

Leadership / Ambassador Awards

Assessed by a **Selection Panel** comprising of a VWA Board representative, a Department of Local Government, Sport, and Cultural Industries representative and the VWA Marketing & Communications Manager.

Young Leader of the Year

Nomination Form

Eligibility:

- ✓ Reside primarily in Western Australia
- ✓ Be aged between 18 and 24 years of age as of the 31 December of the given year.

Criteria (Nominations must demonstrate two or more of the following):

- ✓ Evidenced leadership in the fields of coaching, refereeing, administration, event management, marketing, or sports development. (Minimum of 3 evidenced)
- ✓ Involvement in a Volleyball WA / VWA Affiliated Club / Association Committee(s)
- ✓ Actively pursues and demonstrated personal and professional development.



















Discover Volleyball Ambassador

Nomination Form

Eligibility:

✓ Reside primarily in Western Australia

Criteria (Nominations must demonstrate two or more of the following):

- ✓ Actively contribute to the implementation and promotion of the Discover Volleyball Campaign. This could include organising events, creating marketing materials, or engaging with the community to raise awareness and interest.
- ✓ Demonstrate innovative methods to increase participation in the sport of volleyball. Examples might include developing new training programs, utilising social media platforms to reach a broader audience, or collaborating with local schools and organisations to introduce volleyball to new groups.
- ✓ Show a commitment to inclusivity and diversity within volleyball activities, ensuring opportunities are accessible to all demographics.
- ✓ Exhibit leadership qualities in organising and motivating teams or communities to participate in volleyball initiatives.
- ✓ Demonstrate innovative methods to increase participation in the sport of volleyball. Provide evidence of measurable impacts, such as increased attendance at volleyball events or a rise in membership sign-ups for volleyball clubs.



















Clubs / Association Awards

Please note Affiliated Clubs / Associations that run multiple codes of volleyball may be eligible for multiple Club / Association Awards. To be eligible Clubs / Associations would need to inform VWA of the multiple codes on offer. These awards will be collated by the VWA Administration & Support Team with assistance from the VWA Staff Team.

Champion Club - Beach

Clubs / Associations will only be eligible for this category if they are an affiliated club which includes beach volleyball club in their name and / or operate beach volleyball specific training, programs, and competitions throughout the year's Beach season 2024 / 2025.

Points will be allocated based on the following:

- ✓ Number of Members (Gold and Platinum) who participate in the Clubs's beach training, programs and club social competitions (VWA sanctioned)
- ✓ Number of Beach Kid/Junior/Social Volley Programs
- ✓ Number of coaches involved in AYBVC.
- ✓ Number of referees involved in AYBVC and ATABT State Open
- ✓ Percentage growth of VWA Beach Development Squad, AYBVC State Team athletes, and ATA Tour participants.
- ✓ Number of members on the VWA Beach Committee
- ✓ Number of VWA sanctioned Beach Events hosted.
- ✓ Number of Beach Venues used.

Robyn Fittock Champion Club - Indoor

Clubs / Associations are only eligible for this category if they are an affiliated club which plays in WAVL and WAVJL indoor volleyball in the current season;

Points will be allocated based on the following:

- ✓ Placings for WAVL and WAVJL
- ✓ Number of accredited coaches (points dependent on level of accreditation)
- ✓ Number of accredited referees (points dependent on level of accreditation)
- ✓ Number of Platinum WAVL Members and WAVJL Members
- ✓ Number of coaches involved in AYVC, AJVC, and/or AVSL (previous season)
- ✓ Number of referees involved in AYVC, AJVC and/or AVSL (previous season)
- ✓ Number of State Team athletes involved in AYVC, AJVC and/or AVL (previous season)
- ✓ Top three clubs at duty (least number of duty related penalty points)
- ✓ Attendance at VWA Indoor (WAVL) Committee meetings



















- ✓ Number of education courses / workshops run in the last year.
- ✓ Points deducted for forfeits and player/coach sanctions.
- ✓ Points deducted for non-compliance with WAVL criteria.

John MacKay Regional Association Award

This award acknowledges the important contribution that the Regional Associations make to the volleyball community in the Western Australia.

Points will be allocated based on the following:

- ✓ Number of Platinum & Gold members
- ✓ Number of accredited coaches (points dependent on level of accreditation)
- ✓ Number of accredited referees (points dependent on level of accreditation)
- ✓ Regional Representative on Volleyball WA Board and/or Committees
- ✓ Attendance at VWA State Championships
- ✓ Number of education courses / workshops run in the last two years.
- ✓ Number of Kids and Junior Volley programs
- ✓ Number of Kids and Junior Volley participants

Indoor Beach Federation Centre Award

Selected by the Indoor Beach Federation.

Volleyball WA Club of the Year

This award aims to acknowledge the Club / Association that has contributed most to the development and growth of sport. Note: VWA Affiliated Platinum and Platinum Regional Clubs / Associations are only eligible for consideration of the VWA Club of the Year Award.

Points will be allocated based on the following:

- ✓ Membership growth over a year period (Adult and Under 19 Platinum, WAVJL and Gold full memberships)
 - Membership Growth 23/24 compared to 24/25 (VWA Membership Years)

- ✓ Number of VWA Course Presenters (Coaching & Referee)
 - o Five Points per Presenter
- ✓ Number of Kids Volley, Junior Volley, and Social Volley programs
 - o 5 points per program
- ✓ Number of Inclusion Participation programs delivered Adaptive Volley, CaLD, Aboriginal, LGBTQIA+, Seniors, Female Only
 - 5 points per program
- ✓ Number of Sporting Schools programs facilitated
 - o 5 points per program
- ✓ Number of members involved in VWA committees / working groups.
 - Five points per person
- ✓ Attendance at VWA AGM, Clubs Conference, Awards Dinner and other VWA functions
 - One point AGM attendance
 - One point Annual Dinner attendance
 - Five points Clubs Conference Attendance
- ✓ Good Sports accreditation / Kid Sport provider
 - One-point Good Sports Registration
 - Five points Good Sports Gold Accreditation
 - Five points Kid Sport provider
- ✓ Demonstrated commitment to child safeguarding.



















- Ten points WWCC Record Sheet
- o Ten points each Member Protection Information Officer (MPIO)
- ✓ Host a VWA Sanctioned event.
 - o Ten points per event
- ✓ Connection to or Activities for Local Councils
 - One point per Activity

















Distinguished Service Awards

Service to Coaching

A Service to Coaching Pin may be awarded to a person who has coached (consecutive or nonconsecutive) at a State and / or National level in the following categories

- √ 10 years
- √ 15 years
- ✓ 20 years

Nominations will be ratified by the VWA Board and pins will be presented annually at the VWA Awards Night.

John Sewell Service Award

This Award seeks to recognise the contribution made by an individual to volleyball in WA through long and outstanding service. The Selection Panel will give preference to those nominees who have contributed strongly across more than one field of endeavour as in the outstanding contribution of John Sewell to whom the award is dedicated.

Eligibility

- ✓ At time of service the nominee must have been a member, volunteer, or supporter of Volleyball WA.
- ✓ Demonstrated a minimum of 20 years of service to volleyball in WA.

Criteria

- ✓ A proven record of achievement and / or performance in any of the following:
 - Competing, Officiating, Administration and Coaching
- ✓ A long-term involvement in and commitment to volleyball at a variety of levels
- ✓ A demonstration of the legacy of the nominee's contribution.

Order of Merit

A VWA Order of Merit may be awarded to people who are associated with VWA who make a significant contribution to the aims and objectives of the Association. The Award aims to acknowledge the outstanding contribution of members who have contributed to the efficiency and effectiveness of VWA. A nomination can be submitted to the VWA Chief Executive Officer at any point prior to the VWA Annual General Meeting.





















Nominations may qualify for nomination by completing at least five (5) years of service to the sport of volleyball, or ten (10) years as a VWA Staff Member. Examples include:

- √ 5 years as an active Club / Association committee member
- ✓ 5 years as a member of a VWA Committee
- ✓ 5 years as an official
- ✓ 5 years involvement in the conduct of national championships organised by VWA (AVSL, AJVC, AYBVC and / or AYVC)
- ✓ 10 years of employment (Full time / part time) with Volleyball WA
- ✓ Any combination of the above

Hall of Champions

The VWA Hall of Champions recognises those athletes, coaches and referees who have represented the State of WA in the sport of volleyball at an outstanding level. A nomination can be submitted to the VWA Chief Executive Officer at any point prior to the VWA Annual General Meeting.

Eligibility:

✓ Have retired from representative competition for a period of five years.

Criteria:

- ✓ Have achieved outstanding sport achievement at the highest level (International Standard)
- ✓ Represented WA at the pinnacle of their sport and recognised as a product of the WA sporting system or have established their reputation while a resident of WA.
- ✓ Served Volleyball WA as a sporting ambassador of the highest order.

Life Membership

Life Membership may be bestowed upon any person whose services to the organisation of VWA have been sufficiently meritorious. This award is superior to that awarded for an Order of Merit Award of the Association. A nomination can be submitted to the VWA Chief Executive Officer at any point prior to the VWA Annual General Meeting.

Life Membership may be granted to any individual who fulfills the following criteria:

- ✓ The nominee must be a registered member of Volleyball WA.
- ✓ The nominee has made a significant, sustained, and lasting contribution directly to the development of the organisation of Volleyball WA.





















- ✓ The nominee has provided a minimum of 10 years' service to the organisation of VWA. This service / contribution to VWA has been a voluntary service / contribution.
- Meritorious service and distinctive leadership are two important criteria for consideration for this award.
 Or,
- ✓ As deemed by the VWA Board, Honorary Life Membership may be awarded to a retired Volleyball WA professional who has served with distinction for more than 10 years.

Definitions

Significant, sustained, and lasting contribution defined as the importance and quality of the work service consistently initiated, performed, or undertaken specifically for Volleyball WA.

To be considered, an individual must demonstrate excellence in multiple areas, including but not limited to:

- Leadership and Governance
- Driving growth, cultures and community engagement in WA Volleyball.
- Upholding and modelling Volleyball WA values.
- Innovation and development, introducing new ideas or improving practices.
- Mentoring and capacity building for future generations.
- Creating a legacy or long-term positive impact on the sport in WA.
- Demonstration that their service has been significant and meritorious

Nominations should include specific examples of;

- The individuals influence and contributions.
- Lasting outcomes or systems they established.
- The scope of their legacy across the Volleyball community.

When considering if the service is directly to VWA, a person must consider if the service to the organisation is managed by VWA. Examples could include contributions to the organisation through being on the Board of Management, Coaching / Refereeing for the State representative teams, being a member of one of the organisation's own Committees or Working Groups etc.

A nomination can be submitted to the VWA Chief Executive Officer at any point prior to the VWA Annual General Meeting.

Tips For Writing a Successful Nomination

Consider the Selection Panel's Perspective

Assume the selection panel is independent and unfamiliar with the nominee. Provide a clear and informative introduction.

Be Direct and Specific

Clearly and concisely outline how the nominee meets the award criteria. Avoid vague statements and focus on precise achievements.

Use Supporting Evidence

Strengthen your nomination with specific facts, statistics, and metrics. Concrete evidence enhances credibility and persuasiveness.

Choose the Right Award

Ensure you are nominating the individual for the appropriate award. If in doubt, seek clarification to avoid misalignment.

Avoid Jargon

Refrain from using specialized slang, abbreviations, or acronyms that might not be understood by the panel. Keep language clear and accessible.
